Maryland Human Trafficking Task Force

The Maryland Human Trafficking Task Force (MHTTF) is the state's primary anti-trafficking organization working to combat trafficking through prevention, protection of victims, prosecution of trafficking and partnerships.

About the Task Force:

- The task force was formed in 2007 by the U.S. Attorney's Office, the Attorney General of Maryland, and the State's Attorney for Baltimore City to serve as the lead investigative, prosecutorial, and victim services coordinating body for anti-human trafficking activity in Maryland.
- We are a multidisciplinary team of agencies and organizations committed to a victim-centered approach in the fight against human trafficking in Maryland. Our record of success in identifying and serving a range of labor and sex trafficking victims is irrespective of gender, nationality, sexual orientation, or age.
- Maryland is at the forefront of victim response using forward-looking efforts of investigators, prosecutors, concerned citizens, advocates, and legislators in anti-trafficking efforts to protect human dignity and public safety.
- The task force builds upon existing collaborations among victim service providers to increase the identification of victims and provide a more comprehensive, specialized, and coordinated response to victims' complex long-term needs.
- Multiple state agencies participate in the MHTTF as a force-multiplier in the fight to raise awareness at the local level to expose traffickers, and developing polices to respond to victims in a united front across state systems.
- MHTTF trains law enforcement and prosecutors to ensure that traffickers are held accountable for their heinous offenses.
- Through increasing public awareness, coordinating state policies/protocols, and implementing best practices for investigations, prosecution, victim identification, and victim service response, our message is clear:

In Maryland, victims will be recovered and traffickers will be held accountable for their crimes.

To accomplish our mission, Araminta focuses on the following areas:

- Education and Prevention Araminta provides public awareness and preventive education in schools, churches, and community settings as well as for professional groups including but not limited to social workers, mental health professionals, law enforcement, court officers, medical staff, and educators. In addition, Araminta provides youth trainings to empower every participant to be able to protect themselves and the people they care about from this issue. Programs focus on identifying risk factors, signs and symptoms of trafficking, the impact of trauma and how to respond if trafficking is suspected.
- 2. Restorative Services for Survivors of Child Sex Trafficking –Araminta supports survivors and atrisk girls and those identifying as female between the ages of 12 25. We offer comprehensive care coordination, advocacy and tangible supports. The Esperanza Center, a program of Catholic Charities of Baltimore, provides comprehensive services to immigrants in Maryland. The Criminal Injuries Compensation Board (CICB) is an agency within the Department of Public Safety and Correctional Services that provides financial assistance in the aftermath of criminal victimization. CICB has a victim services coordinator to assist victims with the process or with additional resources when appropriate. Compensation may be provided to any crime victim suffering physical or certain psychological injuries resulting from a criminal act perpetrated in the state of Maryland and reported to the authorities. Application must be made within three years from the date of the victimization. For qualifying claimants, compensation may be provided for medical or dental expenses, lost wages, loss of support, counseling, disability, or crime scene clean-up. Statutory monetary caps apply. Certain documentation may be required.

The DPP victim services unit provides up to date information to victims who are registered to receive notices about an offender who is either in the community or incarcerated. All victims are required to register to receive notification through VINE or by contacting the victim services unit at 410-585-3340. We currently have four coordinators who service the State of Maryland to provide both written victim notifications and to answer phone calls regarding the offender.

Our process is rooted in strong partnerships with service providers that provide emergency and immediate needs to survivors to ensure a level of stability. When survivors are ready and in need of assistance with **housing, education and/or employment**, they can be nominated to EHN. Our trauma-informed Advocates collaborate with nominees on a self-determined Empowerment Plan that spans 12 to 18 months and focuses on housing solutions, financing education, and establishing steady wage employment.

Agency & Program Description:

- 1. Case Management & Crisis Response (DMV): FAIR Girls provides crisis intervention, court advocacy, and comprehensive case management services to sex and labor trafficking survivors, who identify as a female, and are between the ages of 10 and 27. FAIR Girls' case management and advocacy services are aimed at providing trafficking survivors support to address immediate safety and basic needs, including but not limited to: providing clothing, food, safe, stable and confidential housing, intensive individualized case management, access to medical and mental health referrals, access to legal advocacy and translation/interpretation services if needed, as well as, longer-term case management support, counseling and workforce development skill building.
- 2. Community Outreach, Training & Prevention Education (DMV): *Tell Your Friends* (TYF) is a four module, interactive, multimedia prevention education curriculum taught in middle and high school classrooms, after-school programs, youth shelters, and group homes. By providing information regarding human trafficking and commercial sexual exploitation, risk factors, grooming techniques, and healthy relationships, in an age-appropriate and engaging manner, we empower youth to stay safe from exploitation and victimization and help their friends stay safe. The modules focus on topics such as the rights and responsibilities in intimate partner relationships, the nature of sexual victimization and exploitation, the media's glamorization of commercial sex, and the importance of using empowering language. The curriculum emphasizes the risk factors and causes behind CSEC, trafficking, and dating violence and provides youth with a locally-based resource guide that may be used to contact FAIR Girls and a variety low-barrier support services.
- 3. Emergency & Transitional Housing (located in Washington, DC but serving survivors referred from across the country): FAIR Girls provides emergency and transitional housing to survivors of human trafficking and commercial sexual exploitation of children. The FAIR Girls Vida home is a 90-day transitional housing program specialized for survivors of human trafficking and CSEC who identify as female, ages 18-26. The Vida Home is more than a shelter, it is a leadership transitional home for up to six young trafficking survivors at a time. It is a secure town home setting with six beds in a confidential location in D.C. For up to 90 days, Survivor Residents have a warm bed, meals, basic hygienic necessities, skills building, counseling, and transportation assistance to and from work, school, and the FAIR Girls' confidential drop-in center.

At your request, the FBI can notify employer and/or creditor for you, if your victimization causes you to be absent from work or affects your ability to make timely payments to creditors. The Victim Specialist will serve as the point of contact between you and the FBI.

This includes an emphasis on coordinated strategies between local, state, and federal law enforcement to disrupt and dismantle human trafficking organizations and connect victims and survivors of human trafficking to resources and the support needed to achieve safety, self-sufficiency, and awareness of their rights.

The statewide Director of Anti-Human Trafficking Policy, housed at GOCCP, coordinates law enforcement and victim response while monitoring and pursuing funding sources for anti-human trafficking efforts. The Victim Services Unit works to improve access to services for victims and includes the Criminal Injuries Compensation Board as well as the Sexual Assault Reimbursement Unit, which provides reimbursement for the physical examination, collection of evidence, and emergency treatment of individuals with injuries resulting from alleged rape, sexual assault, or child sexual abuse.

Screening of all youth both in out-of-home placement as well as those receiving in-home services will be screened through the use of the CANS and CANS-F to identify youth who may be at risk of trafficking. Youth identified as at risk will receive further screening as well as appropriate prevention services. The Maryland Safe at Home Address Confidentiality Program provides victims of domestic violence, human trafficking, sexual assault and stalking with a legal substitute address to use in place of their actual address in order to keep their location off public record and out of the hands of abusers or traffickers. It was designed to be one part of a safety plan for survivors who have recently moved or

intend to move to a place unknown to their abuser, including shelters. Once enrolled in the Address Confidentiality Program, survivors may register to vote, obtain a Maryland driver's license, enroll in public school, participate in court proceedings, pay taxes, purchase property and access social services without revealing their actual address. The Address Confidentiality Program is legislatively mandated, administered by the office of the Secretary of State, and serves all Maryland residents regardless of immigration status or whether or not the trafficking or abuse has been reported to law enforcement.

The Sexual Assault Legal Institute (SALI) provides direct legal services for survivors of sexual assault and abuse, and legal training and technical assistance for rape crisis centers and other professionals working with survivors. SALI is a statewide program and serves both children and adults. It is part of the Maryland Coalition Against Sexual Assault (MCASA). Resources available include:

- 1. Legal services for survivors for any legal issue related to the sexual assault/abuse, including peace orders/protective orders, immigration (including U and T visas), employment, education, civil rights, family law, crime victim rights, victim compensation and other matters.
- 2. Training and technical assistance for programs working with survivors, including presentations on civil legal needs of sexual assault survivors, sexual crimes and victim rights in the criminal justice system and legal issues for sexual crimes victims who are under 18.
- 3. Input into MCASA's public policy advocacy, including advocating before the Maryland General Assembly.

Diagnostic Center – 16 Beds Serves females 13-19 yrs of age

Boys High Intensity Program – 10 Beds Serves ages 13 -17 DJS and DYRS only

The Diagnostic Center is a residential program providing crisis intervention treatment for adolescent girls classified with acute social and mental disorders, suffering from long-term abuse, neglect and/or abandonment. Out-of-home placement affecting this population commands specialized services and therapeutic psychiatric care. The goal of the Diagnostic Center program is to assess, stabilize symptoms, and recommend the next level of care upon discharge.

The Diagnostic Center provides statewide emergency placement and crisis intervention services to adolescent girls ages 13-19, with the median age 14-16. Typically teen girls admitted are influenced by the effects of long-term abuse, abandonment, and/or neglect affecting their ability to function emotionally, cognitively, and socially. Initial assessments indicate common behaviors ranging from depression, high anxiety, self-destruction, oppositional behavior, inappropriate sexual behaviors, suicidal thoughts, and decrease interest in academic achievement.

The Diagnostic Center is a staff and perimeter secured facility, Clinical Staff service our Human Trafficking Victims to help them bring their journey from victim to survivor. The focus of the treatment is on a developmental process to help work towards his/her full potential. These strategies include: trauma informed care (**CARE model** evidence based) and therapy, rebuilding self-esteem, image, and worth, substance abuse treatment, strength based, domestic violence, specific work around coercion and control, self-care and safety planning, healthy relationships, vocational and life skills training, and social justice where indicated. These aforementioned strategies are achieved through: weekly 1 hour sessions of psychotherapy, weekly trauma therapy 1-2 hour sessions (trauma timelines explored from birth to present age) where indicated, weekly spiritual groups with Liberty Church Partnership, weekly AA groups, weekly art therapy and daily therapeutic art activities, Specific Human Sex Trafficking literature to help with processing (e.g.: Anger Management work book activities, Dialectical Behavior Therapy strategies and exercises for suicidal adolescents (DBT), Cognitive Behavior Therapy.

A Psychiatric and Psychological Evaluation are also completed to determine the level of care and services needed to help the resident to stabilize behaviors plus address mental health issues.

Daily school attendance is required and included as an indicator in the behavior modification system. On staff at the Diagnostic Center is a certified teacher. The education program is recognized by the State of Maryland as an approved Type III School with classwork in science, math, history, and English – taught on the level of the individual.

Recommendations for the future placement of Diagnostic Center residents are made after careful review of records and reports from the various professional staff that comprises the treatment team of the individual.

The Human Trafficking Prevention Project is a clinical program within the Civil Advocacy Clinic at the University of Baltimore School of Law. The HTPP focuses on reducing the collateral consequences of criminal justice involvement for survivors of human trafficking and those populations made most vulnerable to exploitation. Student attorneys will represent survivors of sex trafficking seeking to vacate their prostitution convictions under Maryland's 2011 "vacating convictions" law, as well as provide representation to any client with a history of involvement in the commercial sex industry in federal and state pardon, expungement and shielding cases. Services are free of charge and provided regardless of age, race, ethnicity, biological/assigned sex, immigration status, sexual orientation, or gender identity. HTPP offers the following services:

1. Legal services for individuals with histories of involvement in the commercial sex industry in vacating, pardoning, expunging, or shielding prostitution and other related charges on their criminal records.

2. Training and technical assistance on the availability of post-conviction relief within the state of Maryland, as well as on working with survivors of trauma.

3. Input on state or federal legislation that impacts survivors of trafficking and those at greatest risk, with a focus on human rights and harm reduction principles.

The University of Maryland, School of Social Work (UMSSW)'s Child Sex Trafficking Victims Initiative (CSTVI and Maryland Human Trafficking Initiative (MHTI) work to improve the response to child and youth sex and labor trafficking state-wide through training, advocacy, services, and technical assistance. These programs build infrastructure capacity among state and local child welfare agencies and victim services providers to ensure that trafficked youth and children at risk of exploitation have access to an array of comprehensive, high-quality services. UMSSW serves as the lead agency responsible for project management and evaluation. The work of CSTVI and MHTI seek to:

- 3. Improve victim identification through implementation of a statewide screening tool to identify trafficked youth and children at high risk of exploitation;
- 4. Enhance **victim response** through training and equipping child welfare, juvenile justice, legal, medical and law enforcement professionals with the knowledge and skills needed to effectively assist survivors; and

5. Ensure every victim receives **comprehensive**, **trauma-informed care** by building capacity among service providers and targeting existing gaps in resources.

CSTVI and MHTI also serve as the only reliable source of data on child sex trafficking, using findings to drive research-based policy making and advocacy. For professionals and agencies working with children and young adults, CSTVI offers training and technical assistance on identification and response to sex and labor trafficking, as well as individual case consultation and specialized referrals.
